

# 10 YEARS OF VICTORIES FOR OUR DEMOCRACY



2010

## FREE SPEECH FOR PEOPLE IS FOUNDED

On the eve of the Supreme Court decision in *Citizens United v. FEC*, Free Speech For People is founded to challenge the decision and big money in politics, helping to spark a nationwide movement to reclaim our democracy.



2011

## DEFENDING STATE CAMPAIGN FINANCE LIMITS

We filed the first in a series of amicus briefs to defend campaign finance limits and political equality in Montana. In 2019, the Supreme Court rejected the challenge to the state's campaign contribution limits.



2012

## NEW MEXICO CALLS FOR CONSTITUTIONAL AMENDMENT

We led a successful campaign in New Mexico to pass a resolution calling for a constitutional amendment to overturn *Citizens United*. To date, 20 states and more than 800 communities across the country have passed similar resolutions.



2013

## LAUNCH OF LEGAL ADVOCACY PROGRAM

We launched our Legal Advocacy Program to challenge *Citizens United* and related rulings in the courts, hold corporations accountable, and develop innovative and pathbreaking laws on money in politics.



2014

## VOTE ON DEMOCRACY FOR ALL AMENDMENT

Fifty-four Senators voted for a constitutional amendment calling for campaign spending limits and to get big money out of politics. The amendment was re-introduced in 2019 with bipartisan support and 115 co-sponsors.



2015

## CHALLENGING UNCHECKED CORPORATE POWER

We defended public interest laws against corporate claims of constitutional rights, including a new living wage law in Seattle, a GMO labeling law in Vermont, a rule requiring the disclosure of conflict minerals, and more.



2016

## LAUNCH OF THE CASE TO ABOLISH SUPER PACS

Representing Members of Congress and joined by a bipartisan group of distinguished scholars, we filed a lawsuit against the Federal Election Commission to abolish super PACs. Our case continues to advance in the courts.



2017

## DEFENDING THE INTEGRITY OF LOCAL ELECTIONS

We led a successful campaign in St. Petersburg, Florida to pass the first bill in the country to end super PACs and spending by foreign-influenced corporations in elections. Similar bills are now advancing in several cities and states.



2018

## THE DEFINITIVE LEGAL CASE FOR IMPEACHMENT

As part of our founding and lead role in the impeachment movement, we published the book, *The Constitution Demands It: The Case for the Impeachment of Donald Trump*, detailing the legal grounds for impeachment.



2019

## CHALLENGING CORPORATE CORRUPTION IN POLITICS

Building on our longstanding work to challenge corporate corruption in our elections, we filed a brief defending a Massachusetts law banning corporate contributions to political candidates. The law was upheld.
