I.

THE BURDEN IS SEVERE AND REDRESSABLE

This case does not challenge the constitutionality of the Governor's orders to 2 protect the public from COVID-19. Rather, this case challenges the constitutionality of 3 the Voter Registration Cutoff, as applied during this year's unprecedented pandemic. 4 The Governor told the State at the end of June, over three months after COVID-19 first 5 hit Arizona: "Right now, Arizonans are safer at home. And when you're away from 6 7 home, don't forget to limit social gatherings, stay six feet from others, wash your hands and wear a mask."¹ These restrictions were necessary for the protection of the public 8 health, but had an undeniable effect on voter registration efforts. Enforcement of the 9 Voter Registration Cutoff in the wake of them severely burdens Plaintiffs' rights to 10 register voters. Similarly, after a hurricane struck Florida and Georgia a month before 11 the 2016 general election, the plaintiffs did not challenge the states' evacuation orders; 12 rather, they successfully attacked the constitutionality of those states' voter registration 13 14 cutoffs, as applied in the wake of the disaster. See Pl. Br. (Dkt. 2) at 10.

The severe burden on Plaintiffs' rights is evident not only in Plaintiffs' voter 15 registration data, id. at 6-7, but also Defendant's own publicly-available statewide 16 17 registration data, which clearly shows that from January to August 2020, Arizona netted only 62,565 new registrations, as compared to 146,214 during the same eight-month 18 period in 2016, Salzman Decl. PP 1-7, Exs. A-D. It is a red herring for Defendant to 19 argue "more Arizonans are registered to vote in 2020 than were registered to vote ... in 20 2016." Dkt. 16 at 12. Arizona's total population is larger in 2020 than in 2016,² so 21 necessarily there are more Arizonans registered in 2020. Defendant's own numbers 22 show the *rate* of registration indisputably dropped during the pandemic.³ 23

This severe burden on Plaintiffs' constitutional rights confers standing.
 Defendant mistakenly attributes Plaintiffs' injury to their inability to meet their own
 voter registration goals. Defendant confuses the symptoms of Plaintiffs' injury for the
 injury itself. Plaintiffs are unconstitutionally burdened by Defendant's enforcement of
 the Voter Registration Cutoff because it is preventing them from registering thousands
 of eligible Arizonans. That they are unable to meet their own target registration goals is
 just evidence of the severity of this burden.⁴

Finally, the data cited in Defendant's papers and undisputed evidence in the 8 record prove that Plaintiffs' injury is redressable. Defendant's own Elections Director 9 reports an increase of 234,266 registered voters since January 1, 2020. Dul Decl. (Dkt. 10 18-3) 10. Considering the State netted only 62,565 registered voters between January 11 12 and August, Salzman Decl. P 7, the State clearly saw a massive spike of registrations approximately 171,710 additional voters—*after* restrictions were lifted in August. 13 14 Indeed, Defendant highlights in her papers that 45,024 new or updated registrations were logged on September 22, 2020 alone. Dul Decl. P 11. Defendant's data shows an 15 average of 2,960 additional voters registered each day since the restrictions lifted; if that 16 17 rate continues, approximately 65,120 additional voters will be registered between October 6 and 27, 2020. Salzman Decl. P 8. Plaintiffs estimate their two organizations 18 alone will be able to register approximately 2,000 voters in the extension period, and 19 their broader coalition will be able to register over 25,000. Bravo Suppl. Decl. **P** 3; 20 Bolding Suppl. Decl. **PP** 2,7. 21

signature drives with people who "are already civically engaged," as opposed to the
latter, which is "time-consuming," involves a "detailed registration form," and "almost
always entails a lengthy conversation with the potential voter," who is necessarily not
familiar with the registration process. Bravo Supp. Decl. P 16. Tellingly, these nonparties do not cite any data to dispute the *drop in voter registration* established by
Defendant's own data.

MFV and ACFC have organizational standing because the record demonstrates
 their missions are frustrated by enforcement of the Voter Registration Cutoff and they
 diverted resources to respond. Pl. Br. (Dkt. 2) at 4-5. In any event, Plaintiff Ulises
 Ventura clearly has standing as an individual.

1 2 The *Anderson Burdick* analysis is fact-specific; Plaintiffs' strong showing of burden distinguishes this case from those cited by Defendant and the Committees.⁵

II.

THERE IS NO EVIDENCE OF COMPELLING STATE INTEREST

Because the evidence establishes a severe burden on Plaintiffs' constitutional
rights, Defendant must prove that strict enforcement of the Voter Registration Cutoff is
"narrowly drawn to advance a state interest of compelling importance." *Burdick v. Takushi*, 504 U.S. 428, 434 (1992) (citation omitted). Although this Court specifically
directed Defendant to focus their briefing on this issue, tellingly, neither Defendant, the
Governor, nor the Committees did so. All three briefly asserted boilerplate state
interests without evidence.

The only specific concerns identified are already-existing features of Arizona 11 12 election procedures, even without an extension of the Voter Registration Cutoff. *First*, there is no showing of voter confusion: voters who registered by the original deadline of 13 October 5 are unaffected by the extension; everyone else will either benefit from the 14 extension or will remain unregistered just as they are without an extension. Second, 15 there is no showing that Arizona cannot process registrations while voting is going on; 16 17 the Secretary tellingly does not and cannot say that all registrations filed by October 5 would be processed by October 7 when early voting begins and does not dispute that 18 Arizona already processes some registrations until 7:00 pm on election day. Pl. Br. 19 (Dkt. 2) at 11; Martin Decl. (Dkt. 2-3) P 37-39. *Third*, Arizonans can request to vote by 20 mail at any time by making a one-time request for a ballot-by-mail; this means that, 21 with or without a registration extension, some voters seeking to vote by mail will miss 22

the deadline for this year.⁶ *Fourth*, Arizona's residency requirement is already enforced by requiring voters to show proof of Arizona residency when they vote, not when they register.⁷ *Fifth*, Arizonans are already required to submit proof of citizenship to register to vote in state and local elections; if they fail to do so, they vote on a provisional ballot and their vote is counted only if they timely supply proof of citizenship. The same process will apply to voters who register during the extension.⁸ Martin Decl. **P** 41.

In short, unlike in cases cited by Defendant and the Committees,⁹ here, there is 7 no evidence that an extension of the Voter Registration Cutoff would prevent elections 8 officials from handling these existing features of Arizona election procedure the same 9 way they do every other year in the absence of an extension. See id. PP 19-22, 35-49. 10 The only difference is that an extension will mean they apply these procedures for the 11 benefit of more voters. "Elections administrators are accustomed to meeting urgent 12 needs, particularly in the interest of voter enfranchisement. It is the nature of the work." 13 *Id.* **₱** 34; *see also id.* **₱** 20. 14

Finally, as this Court already held, the County Recorders are not necessary
parties. *Arizona Democratic Party v. Reagan*, No. 16 Civ. 03618, 2016 WL 6523427, at
*6 (D. Ariz. Nov. 3, 2016) (Logan, J.). Nor does the remedy require any changes to
Arizona law or Elections Manual. If the Court finds enforcement of the Voter
Registration Cutoff unconstitutional as applied this year, Defendant will be compelled

by Court order to direct the County Recorders to continue doing what they already are doing, for three more weeks, so that thousands more voters can be registered.

III. PURCELL DOES NOT APPLY TO REGISTRATION EXTENSION

"[T]he factors that animated the Supreme Court's concern in *Purcell* are not 4 present" here because "the injunction at issue here does not involve any change at all to 5 the actual election process." Feldman v. Ariz. Sec'y of State's Office, 843 F.3d 366, 368 6 7 (9th Cir. 2016). An extension of the voter registration period would simply allow more people to register and vote using the processes already in place. "[I]n our case, in 8 contrast to *Purcell*, an injunction will not confuse election officials or deter people from 9 going to the polls for fear that they lack the requisite documentation. The election 10 process is unaffected." *Id.* Judge Rayes reached the same conclusion a few weeks ago 11 12 when he enjoined the State to extend the cure deadline for unsigned vote-by-mail ballots, reasoning: "Plaintiffs are not asking election officials to devise new rules out of 13 whole cloth. They are asking those officials to continue applying the same procedures 14 they have in place now, but for a little longer." Ariz. Democratic Party v. Hobbs, No. 20 15 Civ. 1143, 2020 WL 5423898, at *13 (D. Ariz. Sept. 10, 2020). 16

17 Purcell was also a facial challenge, not an as-applied challenge brought in the midst of the most severe pandemic the world has seen in over a century. See 18 Democratic Nat'l Comm. v. Bostelmann, 447 F. Supp. 3d 757, 770 (W.D. Wis. 2020) 19 (rejecting *Purcell* argument because "some accommodation is necessary to preserve 20 citizens' right to vote amidst this unprecedented public health crisis"); People Not 21 *Politicians Or. v. Clarno*, No. 20 Civ. 1053, 2020 WL 3960440, at *7 (D. Or. July 13, 22 2020) (rejecting *Purcell* argument because "when these rules collide with 23 unprecedented conditions that burden First Amendment access to the ballot box, their 24 application must temper in favor of the Constitution.").¹⁰ 25

26

The Supreme Court recently declined to apply *Purcell* to strike down an
 extension of time for the mailing of absentee ballots; it applied it only to that part of the
 district court's decision that modified election procedures for the counting of absentee

Finally, neither *Purcell* nor laches applies because there was no undue 1 2 delay. "In the context of election matters, the laches doctrine seeks to prevent dilatory conduct and will bar a claim if a party's unreasonable delay prejudices the opposing 3 party or the administration of justice." Democratic Nat'l Comm. v. Ariz. Sec'y of State's 4 Office, No. 16 Civ. 01065, 2017 WL 11503449, at *2 (D. Ariz. Apr. 13, 2017) (citation 5 omitted). The undisputed evidence is that Plaintiffs brought this case as soon as it 6 7 became clear that an extension would allow thousands of additional people to be registered. See Bravo Decl. (Dkt. 2-1) PP 34-38; Bolding Decl. (Dkt. 2-2) PP 22-31. 8 While their injury is now clearly redressable (supra Part I), it would not have been had 9 they brought the case earlier. Nor has there been any showing of prejudice. Supra Part 10 II. 11

IV. POLITICIZED INTERVENTION SHOULD BE DENIED

"[A]n applicant seeking to intervene as of right has the burden to show that all 13 four elements are met." Citizens for Balanced Use v. Montana Wilderness Ass'n, 647 14 F.3d 893, 897 (9th Cir. 2011) (citations omitted). The Committees fail to carry their 15 burden on two elements: significant protectable interest and inadequate representation. 16 17 Their asserted interest—"winning election or reelection" (Dkt. 15 at 4)—is not sufficient because "[t]he requirement of a significantly protectable interest is generally 18 satisfied when the interest is protectable under some law." Arakaki v. Cayetano, 324 19 F.3d 1078, 1084 (9th Cir. 2003), as amended (May 13, 2003) (internal quotation marks 20 omitted). No law protects the right to win an election. An extension of the voter 21 registration period does not favor or disadvantage any particular political party. The 22 proper forum for defending the Committees' interest in electoral victory is on the 23 campaign trail, not in the courtroom. 24

Even if the Committees had a legally cognizable interest—which they do not—
Defendant adequately represents such interests. "The most important factor in assessing

the adequacy of representation is how the interest compares with the interests of existing parties." *Citizens for Balanced Use*, 647 F.3d at 898 (internal quotation marks and citation omitted).

First, there is "an assumption of adequacy here when the government is acting on
behalf of a constituency that it represents, which must be rebutted with a compelling
showing." *Id.* (quotation marks and citation omitted). As this Court noted in *Reagan*, the
Secretary of State "is Arizona's chief election officer who is responsible for overseeing
and administering elections in Arizona." 2016 WL 6523427, at *6 (citing Ariz. Rev.
Stat. § 16-142(A)). Because Defendant is the State's highest elections official, a
presumption of adequacy of representation exists.

Second, adequacy of representation is further presumed because Defendant and 11 12 the Committees seek the same ultimate objective: to defend the Voter Registration Cutoff. See Citizens for Balanced Use, 647 F.3d at 898 (citation omitted) (holding that 13 adequacy is presumed when an intervenor and existing party "share the same ultimate 14 objective"). Here, according to the Committees, "both [Defendant] and the Proposed 15 Intervenors take the position that the voter registration deadline ... is constitutionally 16 17 sound and fully enforceable." Committees' Br. (Dkt. 15) at 7. The Committees' briefing makes the same arguments Defendant's makes. See Def. Opp. (Dkt. 16) at 15 (arguing 18 that "[t]he Deadline does not violate the Constitution."). 19

Third, "[b]ecause [the Committees] and [Defendant's] interests are essentially
identical, the [Committees] may only defeat the presumption of adequate representation
with a 'compelling showing' to the contrary." *Perry v. Proposition 8 Off. Proponents*,
587 F.3d 947, 952 (9th Cir. 2009) (citation omitted). The Committees' speculation that
they may have a different motivation than Defendant fails to carry this heightened
burden. "[M]ere differences in litigation strategy are not enough to justify intervention
as a matter of right." *Id.* at 954 (quotation marks and citation omitted).¹¹ As Chief Judge

The Committees' claim that Defendant may not pursue an appeal of an adverse ruling is entirely speculative and fails to rebut the presumption of adequacy. *See*

Snow found last month in rejecting a similar politically-motivated intervention by the
 Committees, the Secretary of State "is more than capable of defending the
 constitutionality of the [Voter Registration Cutoff] without the Committees' assistance."
 Yazzie v. Hobbs, No. 20 Civ. 8222, Dkt. 45 at 7 (D. Ariz. Sept. 16, 2020).
 The Court should deny permissive intervention for the same reasons. *See United States ex rel. Richards v. De Leon Guerrero*, 4 F.3d 749, 756 (9th Cir. 1993) (denying

permissive intervention where the government party to the case made the same
arguments as the intervenors, and would adequately represent the intervenors' interests).

V.

WITHOUT AN EXTENSION, THERE WILL BE IRREPARABLE HARM

Absent an extension of the Voter Registration Cutoff, Plaintiffs will suffer 10 irreparable harm. Defendant's data shows approximately 65,120 new voters would be 11 12 registered with an extension until October 27, 2020. Salzman Decl. P 8. Plaintiffs' organizations alone will be able to register approximately 2,000 and their broader 13 coalition will be able to register over 25,000. Bravo Suppl. Decl. ₱ 3; Bolding Suppl. 14 Decl. **PP** 2,7. If an extension is not granted, Plaintiffs' voter registration efforts will be 15 halted by the State. At best, Defendant articulated a minimal burden which is wholly 16 17 insufficient to justify severely burdening Plaintiffs' rights and the disenfranchisement of thousands of voters. The balance of the equities favors Plaintiffs, as well as the public's 18 interest in expanding the voting franchise. 19

Freedom from Religion Found. v. Geithner, 644 F.3d 836, 842 (9th Cir. 2011) ("[I]f the
mere possibility that [Defendant] might decline to appeal were sufficient to rebut the
presumption of adequacy, then nearly every case involving [Defendant] would be
subject to intervention as of right."). Defendant has every right to decide not to appeal
based on the uncertainty that an appeal would create during the extended registration
period—a decision the Committees have no right to override.

Per the Secretary of State's own data in Exhibits A–D, cited above, from January to August 2016, the total number of Arizonans registered to vote increased from 3,254,397 to 3,400,611, a net gain of 146,214 voters. From January to August 2020, the total number of Arizonans registered to vote increased from 3,926,649 to 3,989,214, a

net gain of only 62,565 voters. In short, from January to August 2016, Arizona netted more than twice as many additional voters than during the same period in 2020.

8. According to the Declaration of Arizona State Elections Director Sambo Dul (Dkt. 18-3), as of October 1, 2020, 4,160,915 Arizonans are currently registered to vote. *Id.* ¶ 10. As noted above, 3,989,214 Arizonans were registered to vote as of August 4, 2020. Ex. D at 1, 5 (highlighted text). Thus, between August 4 and October 1, 2020, Arizona's voter rolls increased by 171,701 registered voters—a postshutdown registration average of 2,960 net additional voters per day. If registrations were to continue at this rate throughout an extension of the Voter Registration Cutoff to October 27, 2020, Arizona would gain a net additional 65,120 registered voters.



When you arrive to vote at the polls on Election Day you will announce your name and place of residence to the election official and present one form of identification from List #1 or two different forms of identification from List #2 or 3. Valid identification is also required prior to receiving a ballot at any in-person early voting location or emergency vote center or from a special election board. (A.R.S. § 16-542 (https://www.azleg.gov/viewdocument/?docName=https://www.azleg.gov/ars/16/00542.htm); § 16-549 (https://www.azleg.gov/viewdocument/?docName=https://www.azleg.gov/ars/16/00549.htm))

Please note: Members of federally-recognized tribes are not required to have an address or photo on their tribal identification in order to cast a provisional ballot.

Voters with Disabilities

Accessible Polling Places: All polling locations and vote centers have been chosen with special needs voters in mind. Each location will provide handicap parking and be able to accommodate individuals in wheelchairs, as well as, individuals with visual or hearing impairments. Oftentimes a temporary modification will be made to the polling location providing easier accessibility for the voter.

Accessible Voting Systems: All polling locations and vote centers must have an accessible voting device for use by voters with disabilities. In addition to the accessible voting devices, each poling location will have magnifying instruments, large print versions of the publicity pamphlets and trained poll workers who are ready to assist you. View the accessible voting device that will be used in your county (https://azsos.gov/sites/default/files/2020_0709_Election_Cycle_Voting_Equipment.pdf) (PDF).

Curbside Voting: Voters who are unable to enter the polling location or voting center may ask that a ballot be brought to them by an election poll worker.

Permanent Early Voting: Voters who have a permanent physical disability, just like any other eligible voter, may request to be placed on the Permanent Early Voter List (PEVL). This will ensure that they will be mailed a ballot for each election that they are eligible for and allows them to vote from the comfort and convenience of their own home.

Assistance Completing Election Materials: If an individual is unable to sign or fully complete election materials such as a voter registration form, early ballot, and early ballot affidavit, they may be assisted by an individual who is willing to help at that person's direction. This also includes receiving assistance at the polling place by poll workers of two different parties, or an individual the voter with a disability chooses.

HAVA Hotline: The Arizona Center for Disability Law will run a hotline to address any election concerns for persons with disabilities. The ACDL also will file Help America Vote Act (HAVA) complaints.

No. Unless you live in a county that is using vote centers for the election, you must vote at your assigned polling location for your ballot to be valid and counted.

Where Is My Polling Location?

You may locate your assigned polling place through our new Voter Information Portal (https://my.arizona.vote/WhereToVote.aspx? s=address). If you are still unable to locate your polling place you may contact your County Recorder (/county-election-info).

Some Arizona counties utilize vote centers. vote centers are voting locations open on Election Day to every eligible voter in the county. Voters can visit any vote center in their county to receive and cast their official ballot.

I Still Have My Early Ballot, Will I Have To Wait In Line At A Polling Location Just To Drop It Off?

No. If you were unable to mail back your early ballot in time, you can skip the line and turn it in at any polling location within your county. The poll workers will be able to assist and show you where to drop off your early ballot.

What Do I Need To Bring With Me On Election Day?

Every qualified elector is required to show proof of identity at the polling place before receiving a ballot. Find out what qualifies as an acceptable form of identification in Arizona (/elections/voting-election).

Why Did I Have To Vote A Provisional Ballot?

A provisional ballot is given to anyone who is not on the polling location's roster or if the voter was unable to provide a valid form of identification. There are a few reasons why your name was not included on the roster.

- · You recently moved and did not update your voter information in time
- · You voted at a polling place not assigned to you
- You requested an early ballot by mail
- Your voter registration is no longer active or you are not registered at all

I Did Not Have Any ID With Me On Election Day, When Is The Deadline To Provide ID For My Vote To Count?

If you were unable to show valid identification at the polls on Election Day you would have been provided with a conditional provisional ballot. This ballot will be valid and counted as long you provide valid identification to your polling location before 7:00 pm on Election Day. Alternatively, you can present an acceptable form of identification to your County Recorder's Office by 5:00 p.m. on the 5th business day following the election if the election included a federal race, or by 5:00 p.m. on the 3rd business day after any other election.



PHOENIX — Arizona ranked third in percentage growth rate in 2019, according to estimates released this week by **U.S. Census Bureau (https://azgovernor.us3.list-manage.com/track/click?**

u=92fdf4d2c03bdcc82721f4a7b&id=433b2e506e&e=a906a3fa1b). Arizona welcomed more than 120,000 residents from 2018 to 2019, a growth rate of nearly 1.7 percent, which bests states like Utah (1.662), Texas (1.283), Washington (1.210), Colorado (1.185), Oregon (0.857) and New Mexico (0.195).

With a nearly 1.7 percent growth from July 2018 to July 2019, Arizona jumped from fourth to third-highest rate of growth in the nation. The state also ranked third in the number of new residents with more than 120,000 newcomers. Only Texas and Florida added more residents.

"Arizona's budget is balanced, our economy is booming and we have more people choosing our state than nearly anywhere in the country," said Governor Doug Ducey. "With more people and more jobs, Arizona is investing in the things that really matter, like our K-12 public schools, public safety and roads and bridges. The credit goes to the entrepreneurs, innovators, educators, law enforcement officers, volunteers and more who make Arizona the best state to live, work, play and get an education."

Since 2015, Arizona has added an estimated 548,304 residents with a 6.6 percent growth rate during that time. Arizona's estimated 120,693 new residents between 2018 and 2019 more than doubled California's 50,635 new residents. Additionally, two states—Illinois and New York—lost residents, with 51,250 and 76,790 people leaving the states, respectively.

State Policy Reports recently **ranked Arizona fourth (https://azgovernor.us3.list-manage.com/track/click? u=92fdf4d2c03bdcc82721f4a7b&id=56b55b616a&e=a906a3fa1b)** in economic momentum as well as in the top five for growth in personal income, employment and population. Arizona has added more than 300,000 jobs since 2015



ARIZONA HAS A PROUD HISTORY OF SECURE AND RELIABLE VOTING BY MAIL

Most Arizonans already vote by mail, allowing them to fill out their ballot from the comfort of their home and then mail it back or drop it off at any drop-box or voting location in their county.

Due to COVID-19, the Centers for Disease Control and Prevention (CDC) has recommended: https://www.cdc.gov/coronavirus/2019-ncov/community/election-polling-locations.html (https://www.cdc.gov/coronavirus/2019-ncov/community/election-polling-locations.html) early voting and voting by mail when possible.

Registered voters have two ways to get a ballot-by-mail:



You can sign up for the PEVL when you register to vote. Or, if you're already registered to vote, follow the simple steps below to get your ballot-by-mail and ensure you have a safe, secure, and reliable option for voting in this year's elections.

Permanent Early Voting List (PEVL)

Voters on the PEVL are automatically sent a ballot-by-mail for all elections in which they are eligible to vote.



OPTION 1: SIGN UP FOR THE PEVL ONLINE

DEADLINE TO JOIN THE PEVL

There is no deadline to join the PEVL. However, to get a ballot-by-mail for an upcoming election, you must sign up at least 11 days before Election Day.

Important Information Regarding Proof Of Citizenship

A person must be a U.S. citizen in order to register and vote.

A person who submits valid proof of citizenship with his or her voter registration form (regardless of the type of form submitted) is entitled to vote in all federal, state, county and local elections in which he or she is eligible. The voter registration form otherwise must be sufficiently complete.

A person is not required to submit proof of citizenship with the voter registration form, but failure to do so means the person will only be eligible to vote in federal elections (known as being a "federal only" voter). A "federal only" voter will become eligible to vote a "full ballot" in all federal, state, county and local elections if he or she later provides valid proof of citizenship to the appropriate County Recorder's office.

Accepted Proof of Citizenship Information

If you have an Arizona drivers license or non-operating identification card issued after October 1, 1996, you will only need to list the license number on box 9 of the voter registration form.

If you do not have an Arizona license you may need to provide one of the following documents to establish proof of citizenship:

- 1. supporting legal documentation (i.e. marriage certificate) if the name on the birth certificate is not the same as your current legal name
- 2. A legible photocopy of the pertinent pages of your passport
- 3. U.S. naturalization documents or fill in your Alien Registration Number in box 11 on the voter registration form

Supplemental Declaration of Flavio Bravo

FLAVIO BRAVO, pursuant to 28 U.S.C. § 1746, declares under penalties of perjury as follows:

1. I am the Arizona Democracy Collaborative Director of Mi Familia

Vota, a plaintiff in the above-captioned matter. I am authorized to provide this supplemental declaration on behalf of Mi Familia Vota in further support of Plaintiff's motion for a temporary restraining order and preliminary injunction.

2. Mi Familia Vota is a non-partisan civic engagement

organization. Our voter registration efforts are not affiliated with any political party or candidate.

If the Court grants an extension of the voter registration deadline
 until October 27, 2020, Mi Familia Vota will use that extra time to register approximately
 1,500 additional voters.

4. We base that estimate on the fact that, since resuming our in-person registration work, between the end of August and the end of September, we have registered 1,581 new voters. In my declaration of September 30, I mistakenly estimated we had registered 4,500 additional voters in this time period. My estimate now is based on a thorough review of more complete data that we are receiving daily from our organizers in the field.

5. This estimate of 1,500 may be conservative because prior to the pandemic, between January 13 and March 20, 2020, we had registered 9,845 voters; over 1,500 of these were registered in just one week. During this period of time, we were registering on average 1,094 voter per week, which means we were on track to register 41,568 by the October 5 voter registration deadline.

6. Notwithstanding all of the challenges we have faced this year because of the pandemic, Mi Familia Vota has registered a total of just under 14,000 voters so far.

7. If the Court extends the registration deadline, we would undertake immediate efforts to maximize the effects of the extension and we believe those efforts would help us exceed even the estimated 1,500 new voters.

8. First, we would immediately announce the extension by issuing a press release; posting the news on our website; and using our partners, allies, and community organizers to further spread the news.

9. Second, we would use our partnership with Univision to announce the extension of the registration deadline and to encourage people to call our voter

registration hotline.

10. Third, we would immediately hire more voter registration organizers to go door-to-door in neighborhoods we have not yet been able to canvass.

11. Fourth, we would host additional voter registration drive-through events.

12. Fifth, we would coordinate our efforts with the efforts of the other organizations doing voter registration in our One Arizona coalition.

13. The effect of the extension also cannot be considered just by examining Mi Familia Vota's projected numbers in isolation. Other organizations and individuals engaged in voter registration efforts, as well as every eligible voter in the State, would also benefit from the extension. For example, One Arizona, the coalition we are in, had a target of registering 250,000 voters this year. The coalition has already registered 150,000 voters this year and an extension would allow it to register thousands more voters.

14. Mi Familia Vota not only registers voters directly, but we also educate and advise potential voters, and many of these voters register on their own, based on the information that we have provided to them on through direct calls, pamphlets, and our website.

15. Finally, I understand the Republican National Committee is trying to intervene in this case and has argued that because some PACs were able to collect signatures for ballot initiatives, we should have been able to register voters in the same way. Mi Familia Vota also organizes signature-collection for ballot initiatives and that

work is very different from voter registration work in several critical ways. People who are targeted for ballot initiatives are already civically engaged. By comparison, the people we are trying to reach in our voter registration work are not. We do not have a list of unregistered voters. We have to go door-to-door through the communities we serve to educate people about the process of voter registration and the election. This almost always entails a lengthy conversation with the potential voter, unlike the quick conversation typically required to get a signature on a ballot initiative. After we educate the potential voter about the process, we have to help them fill out the detailed registration form—a process that is more time-consuming and more complicated than simply obtaining a signature. For all these reasons, collecting signatures lends itself well to drive-through events for an already-engaged group of people who can be specifically targeted to come out and quickly sign their names. It also means that it was far more feasible to collect signatures during the pandemic through drive-through events or physically distanced brief conversations than it was for us to engage in the close, lengthy conversations required to register voters. Finally, ballot signature initiatives end when the minimum number required to get the initiative on the ballot has been met. But our voter registration work is never over: everyone deserves the chance to register and exercise the right to vote. There is no cap on the number of voters we want to register.

16. We work with vulnerable Latino, immigrant, and allied communities often disenfranchised due to a lack of access to those resources that facilitate democratic participation and electoral access.

17. Our daily efforts facilitate electoral participation for individuals who

would otherwise been entirely disenfranchised.

18. Based on all the numbers available to us as an organization and as a member of the One Arizona coalition, if the Court extends the registration, thousands of additional people will be registered and will be able to vote in this year's election.

Supplemental Declaration of Reginald Bolding

REGINALD BOLDING, pursuant to 28 U.S.C. § 1746, declares under penalties of perjury as follows:

1. I am the Co-Executive Director of Arizona Coalition for Change, a

plaintiff in the above-captioned matter. I am authorized to provide this supplemental declaration on behalf of Arizona Coalition for Change in further support of Plaintiffs' motion for a temporary restraining order and preliminary injunction.

2. If the Court extends the registration deadline, we estimate that Arizona Coalition for Change would be able to register approximately 500 voters between now and October 27, 2020. This estimate is based on our track record of voter registration in August and September 2020.

3. Since the public health crisis improved in Arizona this past August, we have revamped our voter registration efforts and seen a documented rise. In August

and September, we registered 1,343 new voters, an average of 167.88 per week.

To date, in 2020, Arizona Coalition for Change has registered 9,637 voters.

5. This estimate is conservative because if the deadline was extended we would retain and hire on additional staff to register as many voters as possible to meet the new established deadline.

6. We would also continue registration methods such as drive-through voter registration, online voter registration, and registering individuals by phone.

7. We are also members of the One Arizona coalition which has already registered 150,000 voters this year. Since ramping up its voter registration efforts in the last month, the coalition has registered 25,169 voters in September alone. The coalition's registration rate shows a 17% week-to-week growth for the month of September. Projecting that growth rate out from now until October 27, 2020 results in an estimate of the coalition registering an additional 25,340 voters if the Court extends the voter registration deadline.

8. Our voter education and community outreach work also means that, as we promote the voter registration deadline, it will reach beyond the people registered by our organizers.

9. If the October 5 registration deadline was extended, our track record suggests that this rate of registration would continue, we would be able to register thousands of additional voters, and thousands of additional people would get to exercise their fundamental right to vote and participate in our democracy.
