## Fighting To Protect The Right To Vote

We take action to challenge voter suppression, voter intimidation, and unequal voting conditions. We have won key victories in our lawsuits to protect the fundamental right to vote, including rulings that blocked armed agents from intimidating voters at the polls in Minnesota and that extended the voter registration deadline in Arizona during the pandemic, allowing tens of thousands of more voters to access the ballot.

## Holding Insurrectionists Accountable Under Section 3 of the 14th Amendment

We are advancing a groundbreaking campaign to urge Secretaries of State across the country to uphold Section 3 of the 14th Amendment (14.3) and disqualify from the ballot any person who took an oath of office and then engaged in the January 6, 2021 insurrection. This campaign has included a series of historic legal challenges to certain Members of Congress who helped to facilitate the insurrection. We have secured critical court precedents through this campaign for future 14.3 challenges to protect our republic.

## Challenging big money in our elections

We are a leading force fighting to end the dominance of big money in our elections. We challenge foreign corporate influence in elections, advocate for a series of democracy amendments to the US Constitution, and defend state campaign finance reforms. With these bold and innovative actions to overhaul our nation's campaign finance system, we work to ensure all people can participate equally and meaningfully in our democracy.

## Taking On Unchecked Corporate Power

We defend public interest laws threatened by corporate claims of constitutional rights. We fight for reforms that will ensure that corporations can be held accountable under the law. We draft and promote innovative legislation to hold social media companies accountable for engaging in targeted amplification of disinformation and threats of violence on their platforms.

## How we restore and strengthen our democracy:

Since our founding in January 2010, we have played a leading role in the movement to defend and protect our democracy. We are often the first to initiate bold and creative approaches to the critical issues facing our democracy, including being the first organization to launch a campaign to challenge Citizens United; to co-launch a campaign calling for an impeachment investigation of former President Trump; and to develop model legislation to abolish super PACs and end foreign-corporate spending in elections. At this critical juncture for our democracy, this work is needed now more than ever. With our track record of success, legal expertise, and fearless approach, we will continue to work towards a democracy in which all people have an equal voice and an equal vote.
