FINAL DETERMINATION

DATE ISSUED AND MAILED: September 4, 2024

IN RE: Susan Greenhalgh and Free Speech For People v. Fulton County, OOR Dkt. AP 2024-2098 (Consolidated appeal of OOR Dkt. Nos. AP 2024-2098 and 2024-2099)

On July 30, 2024 and August 5, 2024, Susan Greenhalgh and Free Speech For People (collectively "Requester") submitted requests ("Requests") to Fulton County ("County") pursuant to the Right-to-Know Law ("RTKL"), 65 P.S. §§ 67.101 *et seq*. The County did not respond within five business days of receiving the Requests and the Requests were, therefore, deemed denied on August 6, 2024 and on August 12, 2024, respectively. 65 P.S. § 67.901. On August 12, 2024, the Requester appealed to the Office of Open Records ("OOR").

Local agencies have the burden of proving that records are exempt from access. 65 P.S. § 67.708(a)(1). Here, the County did not comply with the RTKL by timely responding to the Request, nor did the County participate on appeal by submitting legal argument or evidence in support of withholding records.² Accordingly, the County did not meet its burden of proof under the RTKL. 65 P.S. § 67.305.

For this reason, the appeal is **granted**, the County is required to provide the requested records to the Requester within thirty days, or, in the alternative, a sworn affidavit or a statement made under the penalty of perjury demonstrating that the records do not exist. Within thirty days of the mailing date of this Final Determination, either party may appeal or petition for review with the Fulton County Court of Common Pleas. 65 P.S. § 67.1301(a). All parties must be served with notice of the appeal. The OOR also shall be served notice and have an opportunity to respond according to court rules as per 65 P.S. § 67.1303, but as the quasi-judicial tribunal adjudicating this matter, the OOR is not a proper party to any appeal and should not be named as a party.³ All documents or communications following the issuance of this Final Determination shall be sent to <u>oor-postfd@pa.gov</u>. This Final Determination shall be placed on the website at: http://openrecords.pa.gov.

¹ Because the appeals involve the same agency, requester, and similar requests, the appeals are hereby consolidated into OOR Dkt. AP 2024-2098. *See* 65 P.S. § 1102(b)(3) (stating that "the appeals officer shall rule on procedural matters on the basis of justice, fairness, and the expeditious resolution of the dispute").

² Having received no submissions from the County, the OOR extended the submission period from August 22, 2024 until August 26, 2024. 65 P.S. § 67.1102(a)(1) (vesting appeals officers with the discretion to establish a schedule for the parties to submit evidence and argument.). Having received no submissions from the County after the extended submission period, OOR administrative contacted the County via telephone on August 27, 2024. On August 30, 2024, the County submitted what appeared to be an untimely thirty-day extension notice, dated August 30, 2024. See 65 P.S. § 67.902(b). On September 3, 2024, the OOR requested clarification from the County regarding the purported extension notice and its legal position. To date, no response has been received.
