Re: Request for Investigations into Unlawful Immigration Actions Against U.S. Citizens in California

Dear District Attorney Jenkins,

Enclosed is a letter that we have sent to Attorney General Bonta and Los Angeles District Attorney Hochman, urging them to investigate and where appropriate prosecute federal officials and agents that have violated California criminal laws in their arrest and detention of U.S. citizens. We are deeply concerned with the number of cases in which federal immigration officials have subjected U.S. citizens to violence, abuse, arrest, and detention. As we state in the letter enclosed here, investigation is warranted if a federal officer commits a crime against *any* resident of California, regardless of the victim's immigration status, but the offenses discussed herein are particularly egregious because they would never have occurred had the officers conducted basic due diligence.

We applaud your recent statements supporting the use of state criminal laws to hold immigration officers responsible for their transgressions. We recognize that President Donald Trump for weeks has been threatening to deploy troops and armed federal agents in your city, and while it appears that this operation is on hold, residents of your city remain at the mercy of federal agents already operating there.

We share the enclosed with you in the hopes that the legal analysis therein is helpful as you prepare a strategy to protect San Francisco citizens and all residents from the unlawful actions of federal officials, who lack immunity when operating outside of their lawful authority. Federal officers who violate state criminal law are only immune from prosecution when they were "authorized to [act] by the law of the United States," and that "in doing that act, [they] did no more than what was necessary and proper for [them] to do." Cunningham v. Neagle, 135 U.S. 1, 75 (1890). That immunity does not, "gran[t] a license to federal officials to flout state laws with impunity." Whitehead v. Senkowski, 943 F.2d 230, 234 (2d Cir. 1991).

Further, President Trump, who has ordered and sanctioned the conduct by federal immigration agents documented in our enclosed letter, is not immune from investigation or prosecution in California for offenses that do not qualify as official acts.

We thank you for your work for the people of San Francisco and your efforts to protect your community in this time of crisis.

Re: Request for Investigations into Unlawful Immigration Actions Against U.S. Citizens in California

Dear Attorney General Bonta and District Attorney Hochman,

We write to ask your offices to open criminal investigations into the unlawful arrests and detentions of U.S. citizens by federal immigration authorities in California. Federal immigration officers are targeting Latino communities, and in their patrols and raids are subjecting members of your communities to unnecessary force, threats, coercion, kidnapping, and unlawful detention in violation of California state criminal laws; and they repeatedly have victimized U.S. citizens during their operations. To be clear: if federal officers commit a crime against *any* resident of California, your offices should investigate regardless of the victim's documentation or immigration status. But this letter focuses on clear evidence that U.S. citizens are being subject to unlawful violence, arrest, abuse, and/or detention because federal immigration officers refuse to conduct basic due diligence, including refusing to listen to the citizens' protestation of citizenship or attempts to provide documentation.

Their status as federal officers does not immunize them from investigation and prosecution in California. Nor is President Donald Trump immune from investigation and prosecution in California for offenses that do not qualify as official acts. We respectfully ask your offices to immediately investigate the alleged offenses, ensure the preservation of relevant evidence, and, where appropriate, prosecute all of those involved as authorized by state and local law.

# Background

Since taking office, President Trump has significantly ramped up efforts to detain and deport immigrants. The administration has recorded more than 400,000

deportations so far and is arresting between 1,000-2,000 people each day.¹ Despite a purported goal of arresting and deporting individuals with serious criminal records, an increasing majority of detainees have no criminal records at all, and only 8% convicted of any violent crime.² The White House set an arbitrary goal of 3,000 arrests per day and continues to pressure immigration enforcement agencies, such as the U.S. Immigration & Customs Enforcement (ICE) and U.S. Customs and Border Protection (CBP), to increase their arrest rates through any means necessary.³ Between January 20, 2025 and June 26, 2025, ICE arrested approximately 8,460 immigrants across California, a 212% increase compared to the five months before Trump's inauguration.⁴

In June 2025, Trump unlawfully deployed 2,000 National Guard troops to California in defiance of Governor Newsom's objection,<sup>5</sup> ostensibly to quell civilian protests against ICE's violent and disruptive raids in Los Angeles.<sup>6</sup> During this unlawful occupation of the Los Angeles, federal immigration troops escalated their already aggressive immigration enforcement tactics and attacks on protesters.<sup>7</sup> Trump has also threatened—and vacillated in his decision—to deploy federal agents to the Bay Area.<sup>8</sup>

Immigration officials are blatantly disregarding federal rules around immigration enforcement and may well be violating California state criminal laws, including crimes of kidnapping, assault and battery, false arrest and imprisonment, and theft. Immigration officers—often while actively obscuring or failing to disclose their identities and affiliations—have physically harmed people and property before even beginning to ask questions, responded skeptically and violently to honest assertions of U.S. citizenship, and severely mistreated detained individuals in their custody and control.<sup>9</sup>

This behavior has been officially sanctioned by Trump himself, who actually believes that his immigration agents have not gone far enough: "I think they haven't gone far enough because we've been held back by the judges, by the liberal judges that were put in by Biden and by Obama." He also stated his comfort with the current tactics "because you have to get the people out."  $^{11}$ 

Ordinary citizens are paying the price for Trump's aggressive immigration strategies. <sup>12</sup> They have been kidnapped from their neighborhoods, on their commute, and outside schools, subjected to baseless and unlawful immigration detention, targeted in each case because of their race or ethnicity or because they were present near anti-ICE protests. Examples, which are by no means exhaustive, include:

• Cary López Alvarado, 13 who was arrested in Hawthorne, CA and detained for several hours by CBP agents while she was in her final weeks of pregnancy. Despite the fact that Ms. Alvarado told the CBP agents that she was a U.S.-born citizen and in her final weeks of pregnancy, CBP agents shoved her, placed in shackles that weighed on her abdomen, arrested her, and detained for several hours. Experiencing sharp abdominal pain after her release, she was hospitalized and went into labor prematurely. Ms. Alvarado was not charged with any crime.

- Andrea Guadalupe Velez, <sup>14</sup> who was heading to work in Los Angeles when a federal immigration agent grabbed her and slammed her to the ground, claiming that she was interfering with the agent's work. Despite stating that she was a U.S. citizen and trying to seek help from nearby L.A. police officers, she was forcibly placed in an ICE vehicle and detained in substandard conditions for two days. Though she was initially and baselessly charged with assaulting a police officer, the charges were summarily dropped with no explanation after her attorney requested body-worn camera footage and witness statements, which she never received. In fact, authorities never provided any evidence proving Ms. Velez's culpability.
- George Retes, 15 a disabled 25-year-old Army Veteran who works as a security guard in Camarillo, California. He was on his way to work when he encountered an ICE roadblock. Officers broke his car window, sprayed him with pepper spray and tear gas, and forcibly removed him from the vehicle. Two officers placed a knee on his back while another knelt on his neck, despite his compliance and repeated attempts to identify himself as a U.S. citizen. He was transported to a Navy base and then to the Metropolitan Detention Center in downtown L.A., where he remained in custody for three nights. His jailers denied him medical care, showers, or fresh clothing and did not permit him to contact his family or an attorney. He was placed on suicide watch after becoming emotionally distraught. Officials provided no explanation for his detention and released him without charges.
- Baldomar Gutierrez, <sup>16</sup> a 15-year-old with disabilities, who was waiting in the car with his mother, Andreina Mejia, outside his high school in Los Angeles when a white truck drove up and two masked men with guns approached on each side of the car. With no reason or basis, the officers pulled them both from the car and separated them and placed her son in handcuffs. Baldomar stated that he was a U.S. citizen, 15 years old, and a student. Ms. Mejia volunteered to get identification for her son from their home, but agents refused the offer. After seven minutes, the officers decided they had detained the wrong person. An officer callously joked that the boy would now have an exciting experience to tell his friends about. No charges were filed against him.

• Javier Ramirez, <sup>17</sup> who was working at an auto body shop in Montebello, CA when masked and armed CBP agents in an unmarked white SUV appeared in the parking lot. One agent pointed him out and said, "Get him, he's Mexican." Though Mr. Ramirez told the officers that he could show them his passport, they violently continued their arrest. Two agents tackled and forced Mr. Ramirez facedown to the ground. While Mr. Ramirez begged for an ambulance and blood dripped down his forehead, they forced him up and drove him to a federal detention center. They also refused to take Mr. Ramirez's medication with him, despite his brother trying to hand it to the officers and explain that Mr. Ramirez needs it to treat his diabetes. While imprisoned, detention center officials refused to allow Mr. Ramirez to speak with his lawyer. After four days in detention, Mr. Ramirez was released on bond, and the charges were later dropped without explanation.

These are just samples of a much longer list of citizens who have been wrongly targeted by immigration officials. Free Speech For People has gathered public reports of federal officers wrongly arresting and/or detaining 26 U.S. citizens in California. Descriptions, along with links to the public sources of information, are included in the appendix to this letter. Each of these incidents—and any other attacks on citizens that have not been publicly reported but which your offices may have knowledge of—merit a full investigation by your offices to determine whether federal officers violated California criminal laws in violently arresting and detaining these U.S. citizens.

# **Basis for Criminal Investigation**

# Federal Immigration Officers Violated State Criminal Laws

Your offices should investigate or order investigations to determine whether federal immigration officials may have violated California state criminal laws in the course of conducting illegal arrests and detentions. Potential criminal violations include, but are not limited to, kidnapping, assault and battery, false arrest and imprisonment, and theft:

- **Kidnapping**, California Penal Code § 207(a) ("Every person who forcibly, or by any other means of instilling fear, steals or takes, or holds, detains, or arrests any person in this state... is guilty of kidnapping."):
  - o Though arrests carried out "in the manner authorized by law" by a peace officer are exempt from the kidnapping statute, Cal. Penal Code § 207(f)(2) (West); Cal. Penal Code § 834 (West); see also Cal. Penal Code § 830.8 (West) (permitting federal law enforcement officers to

exercise the powers of arrest of a peace officer in specific circumstances), arrests carried out *outside* the manner authorized by law are not exempt. *E.g.*, *People v. Alvarez*, 246 Cal. App. 4th 989, 1004, 201 Cal. Rptr. 3d 468, 481 (2016) ("At the point at which defendant began to offer an alternative to jail while driving the patrol car, he was not 'acting under' a lawful arrest but to pursue his own prurient interests. Accordingly, there is substantial evidence to support a finding that the lawful arrest defense did not apply to absolve defendant of criminal liability.").

- As detailed in the section below explaining why immunity does not apply, federal immigration officials are operating outside the manner of law in their interactions with U.S. citizens.
- Assault, Cal. Penal Code § 240 (West) ("[A]n unlawful attempt, coupled with a present ability, to commit a violent injury on the person of another."), and Battery, Cal. Penal Code § 242 (West) ("[A]ny willful and unlawful use of force or violence upon the person of another."):
  - "Under California law, a defendant cannot be convicted of both assault and battery, as every battery includes an element of assault, 'and is, in fact, a consummated assault." Garcia v. City of Merced, 637 F. Supp. 2d 731, 748 (E.D. Cal. 2008) (quoting People v. Lopez, 47 Cal. App. 3d 8, 15, 120 Cal. Rptr. 562, 566 (Ct. App. 1975)).
  - "To sustain a claim of assault and battery against a police officer under state law, plaintiffs must provide evidence that the officer used unreasonable force." *Phillips v. City of Fairfield*, 406 F. Supp. 2d 1101, 1117 (E.D. Cal. 2005).
  - Immigration officials are not permitted to use threats, coercion, or physical abuse—yet, nearly all of the incidents involve the aggressive use of force against relatively passive or cooperative individuals.
- **False Arrest**, Cal. Penal Code § 146 (West) ("Every public officer... who, under the pretense or color of any process or other legal authority, does any of the following, without a regular process or other lawful authority, is guilty of a misdemeanor: (a) Arrests any person or detains that person against his or her will...."), and **False Imprisonment**, Cal. Penal Code § 236 (West) ("[T]he unlawful violation of the personal liberty of another."):
  - o "False arrest and false imprisonment are not separate torts, the former being one way to commit the latter.... A false imprisonment claim based upon an arrest without a warrant merely requires an allegation that there was an arrest without process, an imprisonment occurred and damages." *Garcia v. City of Merced*, 637 F. Supp. 2d 731, 752 (E.D. Cal. 2008).

- O Barbara Stone's arrest exemplifies false imprisonment under California law, as immigration officers arrested the 71-year-old grandmother at the San Diego courthouse and placed her in a small room in the courthouse for eight hours, denied her access to an attorney, and ultimately released her with no explanation.<sup>18</sup>
- Immigration agents also took Adrian Andrew Martinez to a parking structure near the federal jail instead of the jail itself for several hours while officers tried to get him to admit he assaulted them.<sup>19</sup>
- Theft, Cal. Penal Code § 484(a) (West) ("Every person who shall feloniously steal, take, carry, lead, or drive away the personal property of another, or who shall fraudulently appropriate property which has been entrusted to him or her, or who shall knowingly and designedly, by any false or fraudulent representation or pretense, defraud any other person of money, labor or real or personal property, ... is guilty of theft."):
  - In several of these incidents, immigration officers have confiscated and never returned individuals' phones, belongings, or identification, as with Jason Brian Gavidia's identification;<sup>20</sup> Barbara Stone's phone;<sup>21</sup> and Angelica Guerrero's shoelaces, phone, and wallet.<sup>22</sup>

Where facts indicate that immigration officials violated any of these or other state criminal laws while targeting U.S. citizens (or indeed any California resident), further investigation and potentially prosecution is warranted.

# Immunity Does Not Preclude Prosecution

The immunity available to federal officials under the Supremacy Clause of the U.S. Constitution is not available in all circumstances and does not preclude criminal investigation and prosecution here. The Supremacy Clause "is designed to ensure that states do not 'retard, impede, burden, or in any manner control' the execution of federal law." *New York v. Tanella*, 374 F.3d 141, 147 (2d Cir. 2004) (quoting *McCulloch v. Maryland*, 17 U.S. (4 Wheat.) 316, 436 (1819)). It does not protect federal officers who act outside the law or beyond what is subjectively and

objectively necessary and proper. Cunningham v. Neagle, 135 U.S. 1, 75 (1890); Kentucky v. Long, 837 F.2d 727, 744 (6th Cir. 1988) ("Under Neagle, a state court has no jurisdiction if (1) the federal agent was performing an act which he was authorized to do by the law of the United States and (2) in performing that authorized act, the federal agent did no more than what was necessary and proper for him to do."); Battle v. State, 252 Md. App. 280, 258 A.3d 1009, 1021 (2021) (rejecting Supremacy Clause immunity for a Department of Homeland Security officer who was prosecuted for assaulting a civilian outside the scope of his duties and beyond what was necessary and proper). To satisfy the "necessary and proper" prong, "two conditions must be satisfied: (1) the actor must subjectively believe that his action is justified; and (2) that belief must be objectively reasonable." Tanella, 374 F.3d at 147 (citing Whitehead v. Senkowski, 943 F.2d 230, 234 (2d Cir. 1991); Long, 837 F.2d at 744).

If a criminal investigation finds even one of the following—that federal officials lacked legal authority, did not believe their actions were authorized, or could not have reasonably believed so—then state prosecution may proceed. Even if some individual agents are found to have genuinely not understood the law, their superiors—who have ordered, approved, and defended such actions—clearly did, and should be held accountable for violating state criminal laws. The fact that this conduct could involve senior officials in the Trump Administration provides no shield to appropriate investigation and prosecution for criminal acts that do not satisfy the *Neagle* test.

# <u>Federal Immigration Likely Lacked Legal Authority</u>

The law circumscribes the authority of federal immigration officers, including CBP and ICE, to arrest and detain U.S. citizens. Federal immigration officials exceeded the bounds of the law in their warrantless arrests and detentions of U.S. citizens in California and could not have reasonably believed that their actions were authorized under law.

Federal immigration officers are authorized to question people believed to be aliens about their presence in the United States. 8 U.S.C.A. § 1357 (West). "An immigration officer, like any other person, has the right to ask questions of anyone as long as the immigration officer does not restrain the freedom of an individual, not under arrest, to walk away." 8 C.F.R. § 287.8(b)(1) (2025) (emphasis added). In numerous instances involving U.S. citizens in California, immigration officials have restrained the freedom of the individual first and asked questions afterwards, if at all, and only when prompted by the citizen's assertions that they are a U.S. citizen. Indeed, immigration officials repeatedly have ignored the citizen's protestation of their citizenship, refused to allow them to provide evidence, and violently arrested and imprisoned them anyway.

For example, immigration officials tackled Mr. Ramirez and detained him for four days without access to a lawyer or medication, despite being told during his arrest that he could provide them with proof of his citizenship. Heidi Plummer, an

attorney and U.S. citizen, was detained in an immigration raid in a park and only permitted to provide her identification *after* being transported to a detention facility.<sup>23</sup> CBP agents also pushed Jason Brian Gavidia against a wall and physically manhandled him before the agents ultimately confiscated his identification after verifying he was a citizen.<sup>24</sup> Immigration agents also followed the "attack first, ask questions later approach" with George Retes,<sup>25</sup> Angel Piña,<sup>26</sup> Andreina Meijia's minor son,<sup>27</sup> and Rodrigo Almendarez.<sup>28</sup>

A federal immigration officer is permitted to briefly detain a person for questioning if the immigration officer has a "reasonable suspicion, based on specific articulable facts, that the person being questioned is, or is attempting to be, engaged in an offense against the United States, or is an alien illegally in the United States." 8 C.F.R. § 287.8(b)(2) (2025). This regulatory language effectuates the full force of traditional Fourth Amendment protections against unreasonable search and seizure in immigration enforcement. *Sanchez v. Sessions*, 904 F.3d 643, 652 n.9 (9th Cir. 2018); *Sanchez v. Barr*, 919 F.3d 1193, 1200 (9th Cir. 2019) (Paez, J., concurring).

Public reports indicate that while conducting immigration raids, federal immigration officers are detaining bystanders, observers, and protestors without any reasonable suspicion of the person's undocumented immigration status or criminal activity. These detentions appear to be motivated by racial stereotyping, false assumptions based on the victim's proximity to other potentially undocumented individuals, and anger at victims who are lawfully documenting the raids or lawfully exercising their First Amendment rights to oppose the Trump Administration's policies and practices. There are reported instances of federal officers ordering or carrying out an arrest solely because they assume that a Hispanic-presenting individual is not a citizen, as in the incidents involving Cary López Alvarado<sup>29</sup> and Javier Ramirez.<sup>30</sup> Other officers may be using false

accusations to arrest individuals on the ground, as may be the case with Adrian Andrew Martinez,<sup>31</sup> Andrea Guadalupe Velez,<sup>32</sup> and Barbara Stone.<sup>33</sup>

None of these motivations qualify as "reasonable suspicion." Mere assumptions about race,<sup>34</sup> physical proximity to undocumented immigrants or protests,<sup>35</sup> and the exercise of protected First Amendment rights<sup>36</sup> are not grounds for "reasonable suspicion" that a person is undocumented or otherwise warrants arrest. Though the recent Supreme Court emergency stay in *Noem v. Vasquez Perdomo* raises unanswered questions about the role that race may play in identifying undocumented immigrants, even Justice Kavanaugh's concurrence underscores that "apparent ethnicity alone cannot furnish reasonable suspicion" and that questioning of individuals, even with reasonable suspicion, is expected to be brief and minimally disruptive once they clarify that their legal status. No. 25A169, 2025 WL 2585637, at \*1, 5 (U.S. Sept. 8, 2025).

It does not appear that any of the publicly reported instances of U.S. citizens being detained and arrested by federal immigration officials in California meet the basic standard of reasonable suspicion, making such arrests and detentions unlawful and outside the authority of the officers conducting the arrests.

Beyond overstepping constitutional and statutory authority, the conduct of immigration officials also contravenes the regulations that circumscribe their actions, including 8 C.F.R. § 287.8(c)(2)(iii, v)(2025) (immigration officers must identify themselves as an immigration officer authorized to execute an arrest, state

the reason for the arrest, and advise the arrested person of their rights as soon as possible, just like all law enforcement officers); 8 C.F.R. § 287.8(c)(2)(vi) (2025) (anyone arrested by immigration officers on a criminal violation are to be brought "without unnecessary delay" to the appropriate judicial officer); 8 C.F.R. § 287.8(c)(2)(vii) (2025) ("The use of threats, coercion, or physical abuse by the designated immigration officer to induce a suspect to waive his or her rights or to make a statement is expressly prohibited").

If a criminal investigation finds even one of the following—that federal officials lacked legal authority, did not believe their actions were authorized, or could not have reasonably believed so—then state prosecution may proceed. Here, there is strong evidence that at least one—if not all three—of those conclusions is met in many of the circumstances described above. Therefore, federal law enforcement would not be entitled to <a href="immunity from prosecution for violating">immunity from prosecution for violating</a> California criminal law.

## Conclusion

We applaud the actions that California officials have already taken to oppose the Trump Administration's unlawful immigration enforcement tactics. Los Angeles Mayor Karen Bass, Rep. Robert Garcia of Long Beach (Ranking Member of the House Oversight and Government Reform Committee), and Senator Richard Blumenthal (Ranking Member of the Senate Permanent Subcommittee on Investigations) are working together to investigate the immigration crackdown's impact on U.S. citizens.<sup>37</sup> Attorney General Robert Bonta has taken critically important steps to challenge the Trump Administration's attempt to militarize L.A. in response to protests against immigration enforcement actions.<sup>38</sup> We also applaud Attorney General Bonta for leading multistate coalitions in amicus briefs in support of California cities against Trump Administration's mass immigration raids<sup>39</sup> and in

support of the individual plaintiffs suing against immigration officials' unconstitutional and unlawful stops of L.A. residents during immigration sweeps.<sup>40</sup>

Also noteworthy is San Francisco District Attorney Brooke Jenkins's vocal support for using state criminal laws to hold immigration officers responsible for their transgressions: "I have an obligation to ensure that any law enforcement that deployed to San Francisco federally abides by the laws of our state and does not engage in harassment or uses of excessive force or anything else that crosses the boundaries of the law." Speaker Emerita and Rep. Nancy Pelosi has also supported using state criminal laws to arrest federal agents where appropriate. 42

The path forward is clear: where federal officers violate California state criminal law to harm any of its residents—citizens or not, regardless of documentation or status—local and state law enforcement have the authority and obligation to investigate and, where appropriate, prosecute. This applies whether the offender is an ICE agent, supervising official, or the President himself. The crimes listed here are particularly egregious because the federal officers had every opportunity to correct their erroneous assumptions and instead chose, at every turn, to subject citizens to violence, abuse, and illegal detention.

We therefore strong urge your offices to initiate investigations into whether charges should be brought against those responsible for the unlawful assault, arrest, and detention of U.S. citizens in California.

Location: Simi Valley

Length of Detention: Arrested but not detained

Charged: No

Description: Almendarez, who works as a driver for JB Wholesale Roofing and Building Supplies, was handcuffed outside his job by federal immigration agents. They did not say who they were, who they were looking for, or what Almendarez did wrong. Agents let him go only after seeing his ID and hearing his coworker yell that Almendarez was a U.S. citizen. Agents were so eager to detain Almendarez that they left their SUV in drive and the vehicle rolled forward as an agent ran after it. Almendarez said, "I am dark skin, I am Mexican, I am brown. It makes me mad. Really mad. Like I said, I'm American. You know, my background is Mexican, but I was born in this country. They would have got off and asked me, 'hey, sir, we have a question.' I could have answered, but they didn't. They profiled me, just tried to grab me like if I was a criminal." Almendarez has said he plans to file a lawsuit.

Name: Jose Manuel Castillo, Jr.

**Incident Date:** 7/17/2025

Location: Sacramento

Length of Detention: 12 hours

Charged: Yes

**Description:** Castillo is a volunteer for the organization NorCal Resist, which opposes the immigration raids and seeks to document them. CBP agents wearing black masks and camouflage gear chased him through the parking lot of a Home Depot store in Sacramento, where they were conducting an immigration raid targeting day laborers. His wife recorded the incident and yelled to the officers that he was a U.S. citizen. CBP agents still wrestled Castillo to the ground and detained him at a facility in Stockton for 12 hours, where they allegedly beat him. CBP claims that Castillo was chased and detained because he punctured a tire on one of their vehicles. He has since been charged with a misdemeanor of vandalism, which carries a sentence of up to one year in prison and a \$100,000 fine and year of supervised release.

Names: George and Esmerelda Doilez

**Incident Date:** 8/6/2025

Location: Boulevard

**Length of Detention:** 30 min (encounter only, no detention)

Charged: No

**Description:** George and Esmeralda Doilez were heading to a dental appointment and took time on the way to explore Jacumba and the surrounding area for the first time. A dark-colored SUV started following them near McCain Valley Recreation Area, put on a siren, and pulled them over. CBP agents approached wearing masks. Esmeralda recorded the interaction. CBP claimed that they stopped them because "you did U-turns and there's a known alien out in the area." George did not consent to a search and stated that he and his wife were avid campers exploring on their way to the dentist. The agent said, "If you have a dentist appointment, it probably wasn't the best decision to be out in the middle of nowhere." The CBP called a K-9 unit, which detected a small amount of legally purchased cannabis. The agent then said they now had probable cause and that the couple would be arrested if they did not get out for a full search of the vehicle. They conducted a full search, after which the agent stated that he could seize their vehicle and ticket them for having marijuana, but that he would let them off with a warning.

Name: Isaac Dominguez

**Incident Date:** 8/16/2025

Location: Anaheim

Length of Detention: 6 hours

Charged: No

**Description:** Federal officers arrested Dominguez outside the Euclid Car Wash in Anaheim. He had pulled over because he noticed immigration agents at the business. He saw 3-4 black SUVs and a white van blocking access to the car wash. He was watching the scene and "pump-faked" (pretended to throw) a water bottle. Agents threw a smoke canister and chased him down. Video shows uniformed, masked agents tackling him to the ground as he tried to flee through the parking lot. Video shows Dominguez calling out that he "can't breathe" as an agent pins him down. After being held for several hours, Dominguez was released without charges.

Name: Job Garcia

**Incident Date:** 6/18/2025

Location: Hollywood

Length of Detention: 1 day

Charged: No

Description: Garcia, a 37-year-old doctorate student at Claremont Graduate University, works as a Home Depot deliveryman on the weekends to earn extra money for school. Federal agents conducted an immigration raid outside the Home Depot in Hollywood, surrounding the store's parking lot and blocking people from exiting. Garcia was in the parking lot picking up a delivery order and began recording the raid activity. He and others saw agents order a man in his 50s or 60s to step out of his truck and then used a baton to smash the driver's side window. Garcia exclaimed that those agents had no right to be doing that. Garcia and others walked over to the man being detained and began informing him of his rights. Agents lunged at Garcia, and he pushed one of their hands off of him. The agents tackled him and pinned him to the ground, causing him to sustain several injuries. Agents transported him to Dodger Stadium where they verified his U.S. citizenship. Despite this verification, they then transported him to the Metropolitan Detention Center in downtown L.A. where he was held for 24 hours before being released. Garcia has begun the Federal Tort Claims Act process to bring claims.

Name: Jason Brian Gavidia

**Incident Date:** 6/12/2025

Location: Montebello

**Length of Detention:** No detention beyond sidewalk encounter

Charged: No

Description: Gavidia runs an auto body shop in Montebello. Masked and armed CBP agents in an unmarked white S.U.V. appeared in the parking lot and pressed him against a black metal fence. A federal agent pushed him against a wall and demanded proof of citizenship, asking him the name of the hospital where he was born. Gavidia shouted that he was born in the U.S. in East L.A. Agents confiscated Gavidia's Real ID and his phone. The phone was returned to him when he was released, but not his identification. A DHS spokesperson said Gavidia was detained on the street for investigation for interference but was released after being confirmed to be a U.S. citizen. Agents also violently took his friend, Ramirez (also a U.S. citizen) into custody during the same incident. Gavidia has joined a lawsuit challenging immigration enforcement tactics.

Name: Angelica Guerrero

**Incident Date:** 8/20/2025

Location: San Francisco

Length of Detention: 24 hours

Charged: Yes

**Description:** Guerrero, a transgender woman, was protesting ICE with a small group outside one of the immigration buildings in San Francisco when an agent tackled and detained her. No one read her rights to her. She was taken to Alameda County Santa Rita Jail, where the walls were covered in feces and blood. Her friends and family were unable to find her after she was detained until the next morning. Her jailers did not permit her to make any phone calls. When she was released, they did not return her shoelaces, phone, and wallet—those items were allegedly kept as evidence. She was charged with misdemeanors interfering with federal agents and destruction of property.

A white truck drove up and two masked men with guns approached on each side of the car. The officers pulled them both from the car and separated them. Gutierrez had difficulty removing his seatbelt and then was immediately placed in handcuffs. He stated that he was a U.S. citizen, 15 years old, and a student. Mejia volunteered to get identification for her son from their home, but agents refused the offer. After seven minutes, the officers decided they had detained the wrong person. An officer joked that the boy would have an exciting experience to tell his friends about. No charges were filed. Mejia is suing on behalf of Gutierrez and appears to have started a Federal Tort Claims Act case.

Description: López Alvarado is a 28-year-old woman who was in her final weeks of pregnancy at the time of the incident. Her cousin is Alberto Sandoval, who was picked up during the same incident. Masked CBP agents pulled up to a building's private parking lot after following a white pickup truck with two undocumented workers, including López Alvarado's partner. López Alvardo and Sandoval opened the parking gate for her partner and a co-worker. The agents tried to force their way into the parking area, but López Alvarado stated that this was private property. The agents arrested her, Sandoval, and the two undocumented workers. During the arrest, López Alvarado lost her balance as agents shoved her, and she crouched down, holding her belly. During the arrest, López Alvardo told the agents she was due on June 17. An agent responded, "Ok, your baby is going to be born here, but you're from Mexico, right?" She explained that she was born in L.A. at Hollywood Hospital. The agents put her in chains that weighed on her abdomen. She started experiencing sharp pains in her abdomen after she was released and went to the hospital. She gave birth 4 days later. She has not been charged.

**Description:** Martinez was a 20-year-old employee at Walmart. On a work break, he saw ICE agents detaining an older janitor. Martinez spoke up and said that the janitor was a hard worker. Five officers pushed Martinez to the ground and grabbed him by the neck as they forced him into their car. Martinez's knee, shoulders, and back were injured and bruised from the arrest. Martinez was taken to a parking structure by the federal jail, where he was held for hours while officers attempted to get him to admit he assaulted them and did not permit him to call his mother. He was then taken to jail for three days, where he had to sleep on a metal bed. After initially claiming Martinez punched an officer in the face (which is not supported by the video footage), prosecutors charged him with "conspiracy to impede a federal officer." He has been indicted by a grand jury. Martinez ultimately lost his job at Walmart. One of the officers involved in Martinez's arrest was separately arrested off-duty for an incident at a restaurant.

**Description:** Medina is a 28-year-old pregnant woman. ICE agents arrested her and her undocumented mother while exiting a medical appointment. During the arrest, agents roughly pushed her belly against the car in the process. She threw up and complained of abdominal pain. Agents took her to a hospital. ICE's justification for the arrest was an alleged outstanding warrant from a shoplifting charge from 12 years ago that Medina was not aware of. She has not been charged.

This was her fourth encounter with ICE agents and her first arrest. The first time she encountered ICE, on June 12, 2025, agents busted in and caused damage to her home looking for her husband, while Homeland Security Secretary Kristi Noem observed. ICE agents searching for her undocumented husband have repeatedly harassed and followed her. Medina has not been in touch with her husband since that initial encounter.

Description: Ramirez was working at an auto body shop in Montebello when masked and armed CBP agents in an unmarked white S.U.V. appeared in the parking lot. One agent pointed him out and said, "Get him, he's Mexican." Ramirez stated that he had his passport with him and he could show him, but they did not halt their arrest. Two agents forced him facedown to the ground. Video footage shows him being tackled. His friend Jason Brian Gavidia stated that Ramirez was loudly begging for an ambulance and that blood was dripping down his forehead. and then driven to a federal detention center. Ramirez has diabetes and was taken into custody without his insulin, despite his brother trying to give agents his medicine as they arrested him. Detention center officials refused to allow Ramirez's lawyer to speak to his client. Ramirez was released on bond, and on or about July 6, 2025, the charges were dropped.

Two officers placed a knee on his back while another knelt on his neck, despite his compliance and repeated attempts to identify himself as a U.S. citizen. After several hours sitting in the dirt, agents transported him to a Navy base and then to the Metropolitan Detention Center in downtown L.A., where he remained in custody for three nights. His jailers denied him medical care, showers, and fresh clothing and did not permit him to contact his family or an attorney. He was placed on suicide watch after becoming emotionally distraught. No one provided an explanation for his detention and he was released without charges. He is seeking accountability through the Federal Tort Claims Act.

Description: Shouhed is a carwash owner in Van Nuys. Masked agents entered the carwash in the morning, and one of them pushed Shouhed down as he entered. As one of his employees was being detained outside, Shouhed went outside to prove his employees were authorized to work, but the agents swore at him, pushed him, and violently body-slammed him onto the pavement. Three agents jumped on his back, pulled his arms back, and handcuffed him, despite his protests that he was recovering from heart surgery and needed medical attention. The officers detained Shouhed for nearly 12 hours at the Metropolitan Detention Center in LA, even after agents knew his citizenship status. They did not permit him to call his family. After his release, he was treated at the hospital for broken ribs, post-concussive symptoms of a traumatic brain injury, and injuries to his elbows. His arm had extensive bruising. DHS claims Shouhed impeded the operation and was arrested for assaulting and impeding a federal officer, though no charges were filed.

Description: Trebach, a registered nurse and member of a community group Union del Barrio, was participating in a Harbor Area Peace Patrol outside the Terminal Island staging area, a Coast Guard base used by ICE and CBP to prepare for raids across Southern California. Agents pinned her to the ground and taken into a dark-colored van with no visible markings on the vehicle. CBP stated that Trebach was blocking federal agents from doing their jobs at Terminal Island in San Pedro. She allegedly jumped in front of moving vehicles, hit the car with her signs and fists while yelling, and was ultimately arrested for impeding and obstructing federal law enforcement. Union del Barrio representatives stated Trebach did not attack anyone—rather, the federal agents charged at her and she dropped the poster. Officials have not released any evidence of said crimes. Trebach was released from detention after two days without any criminal charges. The local councilmember, Tim McOsker, reported the arrest to the Port Police who have jurisdiction over that area.

**Description:** Jeane "Blue" Wong, a preschool owner, was one of a group of demonstrators protesting ICE agents as they sought to detain a man. The ICE agents were dressed in plain clothes, masked, without any nametags or identifying information. Wong live-streamed the operation while yelling at the agents. Wong allegedly pressed herself against the police tape when an ICE agent grabbed her. Agents arrested Wong and took her into detention for 20 hours. They did not permit her to use the phone to call her wife and they did not provide access to the restroom. An agent finally relented and agreed to call her wife on her behalf after she promised to stop singing in her cell. She pled not guilty to assault charges.
